## CETEC Research and Knowledge Management, Fall 2021 CHILDREN AT RISK -Texas

CHILDREN AT RISK is currently seeking candidates to fill a Fall 2021 internship position to conduct research and improve knowledge management for the **Center to End the Trafficking and Exploitation of Children (CETEC)**. These efforts will document best practices and lessons learned from some of CETEC's most innovative programs, and make this knowledge more accessible within CHILDREN AT RISK and for our external partners, to maximize the effectiveness of anti-trafficking efforts.

The selected candidates will have the opportunity to learn from a dedicated and collaborative team of researchers and policy experts who use strategic research to influence policy decisions and collective action. Candidates can be at the college, graduate school or PhD level. The internship is open to anyone in Texas and can be fulfilled in person in the Houston or Dallas office, or remotely.

For three years, CETEC has piloted CEASE (Cities Empowered Against Sexual Exploitation) teams of Cyber Patrol volunteers and a chatbot to engage, educate, and dissuade buyers from participating in the sex market. **Key responsibilities include:** 

- Interview CEASE teams to document their insights about the most and least effective ways to engage buyers, as well as what kind of chatbot messaging content best engages buyers.
- Help organize these and other findings/resources into CHILDREN AT RISK'S internal knowledge management system in a way that maximizes accessibility for staff use.
- Work with CHILDREN AT RISK'S communication team to do the same on CETEC's website to maximize accessibility of external resources for partners and the public.
- **Trigger warning:** this project will have exposure to sensitive, potentially disturbing content.

## Final products of this internship include:

- 1. Clear, concise report (15-20 pages) on CEASE learnings and most effective practices for establishing and running Cyber Patrols
- 2. More organized/accessible internal knowledge management of CETEC resources
- 3. CETEC website updated with most recent resources/information

**Preferred qualifications:** We are seeking dedicated, focused candidates who fit the following criteria:

- Current undergraduate, masters student, or PhD student in Texas
- Strong research and writing skills
- Ability to synthesize and effectively communicate complex information
- Strong time organization and coordination skills; attention to detail
- Strong work ethic and ability to work both individually and in a team-oriented environment
- Comfort in Microsoft Word, Excel, Powerpoint, Outlook, Teams, and SharePoint
- Experience with other knowledge management software is a plus
- Intellectual curiosity, openness to a range of perspectives, and appreciation for the complexities of anti-trafficking work

A passion for social justice issues, along with the belief that education and advocacy on children's issues are essential for societal improvement are strong plusses.
