This is a unique position that will enable the selected candidate to understand the day-to-day operations of a successful, macro-level non-profit organization. This position will focus on supporting grant prospect research and writing, and grant report writing, among other activities.

Key responsibilities include:

- Study and understand organization goals, programs, and financial needs.
- Research grant opportunities from Foundation, Corporate, and Government entities.
- Determine proposal concept by studying requests for proposals (RFP), attending grants information sessions, studying past funding patterns including reviewing 990s, clarifying organization needs and opportunities with Grants team, and attending weekly grant strategy meetings.
- Draft and update grant proposals and supporting documents based on the RFP requirements, funding requirements of the organization, and feedback from grants team and program directors.
- Meet proposal deadlines by establishing priorities and target dates for grant research, writing, review, approval, and submission deadlines.
- Respond to internal and external queries on drafted and submitted proposals.
- For approved proposals, track grant reporting deadlines and work with programs team and grants team to prepare and submit grant reports in a timely manner.
- Work closely with the DonorPerfect database to maintain and update donor records in a timely manner.

- Prior grant writing experience is preferred, but not required.
- BA/BS is preferred, but not required.
- Ability to work independently/as a self-starter, as well as a team member.
- A strong desire to learn about grant writing, reporting, and fundraising.
- Comfortable with databases, updating and running reports, etc. However, knowledge of DonorPerfect is not required.
- Strong written and verbal communication skills for both internal and external audiences.
- Project management experience with a strong ability to prioritize multiple tasks.
- Strong attention to detail and a commitment to maintaining accurate, confidential donor records.
- A strong work ethic, ability to work well with others, and a zeal for relationship building are all considered a plus for this position.
