Jennifer Newman, Executive Director, National Center for Missing & Exploited Children

Jennifer Newman is an Executive Director at NCMEC, overseeing NCMEC's Austin, Texas branch office and, operationally, focused on international engagement and special projects in the Exploited Children Division (ECD). Ms. Newman started with NCMEC in 2001, and has spent the past 23 years working cases, helping build programs, and engaging in the issues in the fight against the sexual exploitation of children.

In her current role, Ms. Newman helps ECD leadership in the development and implementation of ECD program policies and processes, as well as expanding international reach and relationships. 
For over 22 years, Jennifer has presented at various national, local and international trainings, and conferences related to the sexual exploitation of children.

# Officer Cory Wright, Internet Crimes Against Children (ICAC) Investigator, Fort Worth Police Department

Officer Cory Wright is an Internet Crimes Against Children (ICAC) Investigator with the Fort Worth Police Department, serving as a member of the North Texas ICAC Task Force and the U.S. Secret Service Cyber Crime Task Force. Cory has been working online child exploitation cases for over 3 years.

Cory investigates and files state and federal charges against individuals involved in the possession, creation, and distribution of child pornography, as well as adults soliciting minors for sex or sexual content through digital platforms. Beyond reactive investigations, he hosts and participates in undercover chatting operations to proactively identify and apprehend child predators. Cory also engages with communities by visiting schools, churches, and events to educate the public on internet safety for minors.
